### **Article 1: Purpose**

(1) The purpose of this Social Contribution Policy (hereinafter referred to as this “Policy”) is to prescribe the basic principles and strategic directions of the social contribution activities of APR Co., Ltd. and its domestic and overseas subsidiaries (hereinafter referred to as the “Company”), in order to fulfill its social responsibilities as a corporate citizen and contribute to the sustainable development of society.

(2) Under the slogan “Better Life,” the Company collaborates with diverse stakeholders to address social issues and create shared value, ensuring that the value generated through its business activities grows alongside society.

### **Article 2: Scope of Application**

This Policy applies to all social contribution activities conducted by the Company.

### **Article 3: Basic Principles**

(1) The Company shall pursue social contribution activities that contribute to its long-term growth and the sustainable development of society.

(2) The Company shall promote continuous and responsible social contribution activities rather than one-time donations.

(3) The Company shall leverage its core competencies, including technology, brand, products, and human resources, in carrying out its social contribution activities.

(4) The Company shall create social value through collaboration with diverse stakeholders, including local communities, non-governmental organizations, and public institutions.

(5) The Company shall manage and disclose the planning, implementation, and performance of its social contribution activities in a transparent manner.

### **Article 4: Key Focus Areas**

The Company’s social contribution activities shall focus on the following areas:

#### **1. Community Support**

The Company shall carry out donations and support activities to promote community development and assist the socially disadvantaged, including supporting vulnerable groups, partnering with local welfare institutions, and providing disaster relief and recovery assistance.

#### **2. Support for Future Generations**

The Company shall support the development of the potential and capabilities of adolescents and young adults through educational and hands-on programs, as well as various initiatives for growth and development.

#### **3. Environmental Protection**

The Company shall promote environmental protection and climate change response through eco-friendly campaigns, closed-loop recycling, carbon reduction initiatives, and participation in environmental conservation projects.

### **Article 5: Implementation Framework**

(1) The Company’s social contribution activities shall be centrally managed by relevant departments, including PR and ESG.

(2) The Company may collaborate with external organizations, non-profit organizations, and public institutions to ensure the effective implementation of its social contribution activities.

(3) Major social contribution activities shall be carried out in alignment with the Company’s sustainability strategy.

### **Article 6: Operation and Management**

(1) The Company shall establish a framework for the planning, implementation, and performance evaluation of its social contribution activities.

(2) Financial resources allocated to social contribution activities shall be managed and disbursed transparently in compliance with applicable laws and internal regulations.

(3) The Company shall regularly monitor and review the outcomes of its activities to enhance their effectiveness.

### **Article 7: Amendment and Repeal**

Any amendment to or repeal of this Policy shall be subject to the approval of the Representative Director.
